MR. WALL: If I can steal a phrase from Mr. Patty, I guess my secretary got overly enthusiastic with the delete button and several paragraphs got omitted, and this simply puts them back in.

MR. TODD: Yes, and what were those paragraphs?

MR. WALL: A better part of the ordinance. All of Subparagraph C on 7-4-12, all of Subparagraphs 1, 2, 3, and 4 were deleted -- [End of Tape 1] --

CLERK: Go ahead.

MR. WALL: -- Paragraphs 1 through 4 were deleted. On 7-4-14, the same thing, Paragraphs 1 through 5 or Subparagraph A were deleted. And I don't know what happened, but they were deleted when the code was adopted in the final version.

MR. TODD: Thank you, Mr. Mayor. No further discussion.

MAYOR SCONYERS: Further discussion now, gentlemen? Is everybody satisfied? All in favor of Mr. Zetterberg's motion to approve, let it be known by raising your hand, please.

MOTION CARRIES 9-0.

MAYOR SCONYERS: 64, please?

CLERK: Mr. Todd and Mr. Handy would like to offer the following as nominees for appointment.

MR. TODD: To the Human Relations Commission, Ms. Nadine Horne.

MR. HANDY: Animal Control, Lester Earl Thompson; Aviation-Bush Field, Mr. Frederick Benjamin; Aviation-Daniel Field, Belle Clarke; Historic Preservation, Annie Powell; Human Relations Commission, Reverend Larry Fryer; Trustee Board, Clara Hornsby; Personnel Board, Dr. Velma Curtis; Planning Commission,

Thelma Mack; Riverfront Development, Bonnie Rueben; Tree Commission, Roy Simpkins; Housing and Neighborhood Development, George Cunningham.

MR. TODD: Mr. Mayor, I so move that we approve.

MR. HANDY: Second.

MAYOR SCONYERS: Motion by Mr. Todd, seconded by Mr. Handy. Discussion, gentlemen?

MR. TODD: Yes, Mr. Mayor. Mr. Mayor, I'd like to point out that Ms. Nadine Horne don't live in District 4, I believe she lives in District 3, but certainly Ms. Horne has done a good job on the Human Relations board the approximately two years that she's been there. And I don't have a great deal of interest in District 4 to serve, and I believe that this would be the only Native American and female on the board unless there was another female appointed today. And where there's no requirement that there be females, that it's just, I guess, the criteria set up by law as a minority-majority community, I think this adds to that board. And we had a Native American issue several years ago during Lock and Ham Jam, and Ms. Horne was appointed to try to avoid those kind of issues. Thank you.

MAYOR SCONYERS: Any other discussion or comments, gentlemen? All in favor of the motion to approve, let it be known by raising your hand, please.

MOTION CARRIES 9-0.

CLERK: 64-A is the communication from the Attorney regarding the Coliseum Authority appointments, along with the Administrator.

MR. WALL: I don't know whether a corrected sheet has been distributed to you or not. Let me point out one thing insofar as Item 64 is concerned. The terms for the two legislative appointments expires in the Year 2000, March of 2000 rather than 2001. Also, on the second page, again, those appointments would expire in the Year 2000, with the exception of one position which will expire in March of '98. The other terms that expire in 1998 are odd number districts and, therefore, I'm recommending that the appointment for District 7 be the one that would expire in March of '98, so you would be filling an unexpired term in that one appointment. I've spoken to Mr. Jerry Brigham about that.

The other people would remain on there. Mrs. Blackwood would remain as the appointment representing -- and she would be from District 3; Bonnie Rueben, District 1; Jordan Wright, District 5. The legislative appointments, I put down the districts that they live in just for informational purposes. And the unrepresented districts will be 2, 4, 6, and 8 for the terms to expire March of 2000, and District 7 would expire in March of '98.

MR. TODD: Mr. Mayor?

MAYOR SCONYERS: Mr. Todd?

MR. TODD: Mr. Wall, are you saying there wouldn't be an appointment for District 4 until the year --

MR. WALL: It is a vacant position that would be appointed, and what I -- Mr. Oliver had circulated a memo recommending that even though the appointments for the Coliseum Authority are to be made by the body as a whole, that since there were eight districts -- or eight appointments, with the exception of the super districts, each one of the Commissioners representing a single district would make an appointment for that district or suggest a name for the full Commission to ratify. My understanding is that the two Commissioners representing the super districts have consented to that. I've not spoken directly with either Mr. Mays or Mr. Kuhlke, but I've been told that they were in agreement. So the idea is that the Commissioners from Districts 2, 4, 6, 7, and 8 would suggest names and then the Commission as a whole would approve those.

MR. TODD: Thank you.

MR. BEARD: Mr. Wall, am I to understand -- or am I correct that the Bill does certify that these individuals appointed should reside in that district or be appointed from that district?

MR. WALL: I'm sorry, I may have to get you to clarify this. This is a non-Section 13 --

MR. BEARD: I'm talking about the appointments from as far as the Bill states. Does it state that they are supposed to reside in that district if we make these appointments? For example, if someone makes the appointment from whatever district, if the Commission makes that appointment, is it true the Bill calls that that person should reside in that district or what?

MR. WALL: Well, the answer -- short answer to that question is no, because I think we're confusing two things. First of all, this is a board or authority that is not directly affected by the Consolidation Bill because it -- the Coliseum Authority is created by a separate act. That act called for four City Council appointees, four County Commission appointees. Obviously now with consolidation there are eight appointments to be made by the Consolidated Government. It does not call -- since this Bill -- the Coliseum Authority legislation stands on its own and it does not require that they live in a specific district.

MR. BEARD: So you're saying authorities -- appointees can come from anywhere within the city?

MR. WALL: That's correct.

MR. BEARD: But the others would have to live in that district if they are --

MR. WALL: If they live in a Section 13 -- excuse me, if they are representing a board or authority that is affected by Section 13 of the Consolidation Bill, the idea is that they would live in that district. But the Bill does not compel them to live in that district. Just as Mr. Todd has pointed out with regard to Nadine Horne, he has recognized that, you know, in that situation and has suggested that someone who does not live in that district be appointed to fill his position from District 4. So it doesn't require that, it says so that each district is represented. But those are Section 13 boards and authorities, the Coliseum Authority falls outside of that.

MR. BEARD: Just wanted a clarification.

MR. TODD: Yes. And, Mr. Mayor, when we're getting into clarifications, Mr. Wall, what do the Bill say in the sense that we don't get in trouble with the minority-majority community. Would Ms. Nadine Horne qualify as a minority as a Native American? I know we've already took that action, but I think that it may be important to clear that up. And maybe you can bring that back to us at a later date, and if we need to make a correction, then we will.

MR. WALL: Okay. I mean, the -- she was appointed to the Human Relations Commission, I believe; is that correct?

MR. TODD: Yes, as a minority member.

MR. WALL: And the Human Relations Commission is supposed to be brought -- made up of representatives from various segments of the community, and Native American is one of the categories to be represented.

MR. TODD: Thank you.

MAYOR SCONYERS: We don't need to vote on that or anything, do we, Jim?

MR. WALL: Not unless someone wants to bring forward a name.

MR. TODD: Mr. Mayor, I move that we receive it as information.

MAYOR SCONYERS: Thank you, Mr. Todd.

MR. WALL: Mr. Mayor, I would point out, one of the reasons that we were requested to put this on the agenda for today is the fact that even though the authority members serve until a successor is appointed, apparently they are having difficulty having a quorum at their meetings because some of those whose terms have expired are no longer attending, so there is some need

BACKGROUND:

Section 13(f) of the Consolidation Act and charter provides that:

"Except as provided by this Act or prohibited by the general laws of this state, the membership of all boards, commissions, committees, panels, authorities or other entities appointed by the Board of Commissioners of Richmond County or the governing authority of the City of Augusta . . . shall be increased by creating two new members for each who shall be recommended by the Richmond County Delegation in the General Assembly of Georgia and appointed by the Commission-Council established by this Act in accordance with the existing laws or ordinances for the appointment of members to such entities . . . [T]he Commission-Council shall identify those boards, panels, authorities, or other entities the membership of which is not comprised of persons who reside in each Commission-Council District and shall propose a plan for each such board, commission, or entity to expand or contract the number of members thereof so that as soon as practical, each such entity shall consist of one member

from each Commission-Council District."

ANALYSIS:

It is proposed that the following policy be implemented to make appointments to these Section 13(f) boards, commissions, and authorities, to-wit:

- No sitting member of any board or commission shall have his term ended prematurely, allowing that member to complete the balance of his term. Sitting members from multiple districts would be assigned to represent an otherwise unrepresented district.
- All ordinances creating these boards will be amended as necessary to provide for 4 year terms after the initial appointments are phased in.
- Terms will be staggered such that the board appointment for a particular district corresponds to the term of the commissioner elected for that district.
- Terms for board members be established such that they expire on March 31 of the applicable year so that newly elected commissioners would have the first 90 days to consider the appointments from his district to the various boards.
- Ex officio members from the Commission would be appointed to the Aviation Commission (Bush Field), the General

Aviation Commission (Daniel Field), the Augusta-Richmond County Public Library, and the Planning Commission. These members would be non-voting members, and would be appointed as are committee chairmen under the consolidation charter.

- There will be no term limits established for members of the various boards, authorities, and commissions.
- There must be a talent bank form included in the agenda book in order for an individual to be considered for appointment to such a board, commission, or authority.
- Ongoing ads will be placed in the daily newspapers for submission of talent bank forms.
- Appointments to these boards and commissions will be accomplished by April 30, 1996.

This Commission is created by virtue of County Code Part II, Chapter II, Article XIII. Section 2-203 states that "There is hereby created a Commission whose title shall be 'The Historic Preservation Commission of Richmond County, Georgia'."

b. Statement of Purpose.

The purpose of the Commission is to "establish a uniform procedure for use in providing for the protection, enhancement, perpetuation and use of places, districts, sites, buildings, structures, objects, landscape features, and works of art having a special historical, cultural or esthetic interest or value, in accordance with the provisions of this article." Section 2-201.

c. Appointments.

The Commission is to consist of five members appointed by the Board of Commissioners of Richmond County. Members must be residents of the County and have demonstrated an interest, experience or education in the area of history, architecture or preservation of historic resources. If possible, at least three (3) members should be professionals in architecture, architectural history, planning, archaeology or related disciplines. Members serve three (3) year terms and may not serve more than two (2) consecutive terms. Initial appointments were staggered. Members may be reimbursed for expenses but do not receive a salary. (This Commission has not been very active for the past three (3) years).

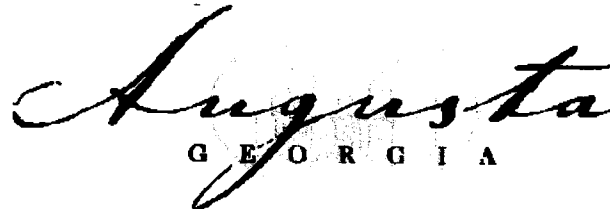

WHEREAS, the Augusta, Georgia EEO Policy provides equal employment opportunities regardless of race, color, religion, national origin, sex, age, disability, military service or status, veteran status, citizenship status, or any other characteristics protected by federal, state, or local law;

WHEREAS, there is a need to expand the Augusta, Georgia EEO Policy so as to broaden the sex discrimination definition to include acts of gender stereotyping and to prohibit discrimination based upon gender, gender expression, gender identity, and sexual orientation;

NOW, THEREFORE, THE COMMISSION OF AUGUSTA, GEORGIA HEREBY RESOLVES to support revisions to Augusta, Georgia's EEO Policy so as to prohibit gender stereotyping for Augusta, Georgia employees in the areas of gender, gender expression, gender identity, and sexual orientation.

THIS RESOLUTION supersedes any other previous resolutions, proclamations, or directives in conflict. THIS RESOLUTION shall take effect immediately and shall remain in effect until such time as the Commission rescinds it.

Caption:	Motion to approve Resolution of Support for the expansion of Augusta, Georgia's EEO Policy so as to prohibit discrimination based on gender, gender expression, gender identity, and sexual orientation.
Background:	The Administrative Services PPPM Subcommittee agreed to include additional inclusion language to the EEO Policy Statement of the Personnel Policies and Procedures Manual. The inclusion language will expand the existing EEO policy statement so as to prohibit discrimination based on gender, gender expression, gender identity, and sexual orientation. These additional four (4) protections are to be included in the permanent language of future EEO policies approved by the Commission.
Analysis:	In concert with federal and case law, there is a legal basis for local government regulation prohibiting gender stereotyping. Based on U.S. Supreme Court decisions,gender stereotyping such as sexual orientation and gender identity, although not explicitly listed as protected classes, are characteristics that can constitute sex discrimination and harassment. The EEOC interprets and enforces Title VII prohibition of sex discrimination as forbidding any employment discrimination based on gender identity or sexual orientation.
Financial Impact:	The revision of Augusta Georgia's EEO Policy to include the prohibitions of sex discrimination by further defining gender stereotyping is a statement of employment inclusion. Including the four (4) additional characteristics is a commitment to equal employment practices for all qualified applicants and employees. At this point, there is no financial impact for the adoption of the Resolution of Support to add additional characteristics to the current EEO Policy Statement. Future financial impacts -

increasing awareness of prohibited acts of discrimination and providing clarification of gender stereotyping could reduce the risk of adverse findings of sex discrimination and harassment.

Alternatives:

Decline to approve the Resolution of support at this time.

Recommendation:

To approve the Resolution of Support to expand the current EEO Policy Statement to prohibit gender stereotyping with respect to gender, gender expression, gender identity, and sexual orientation.

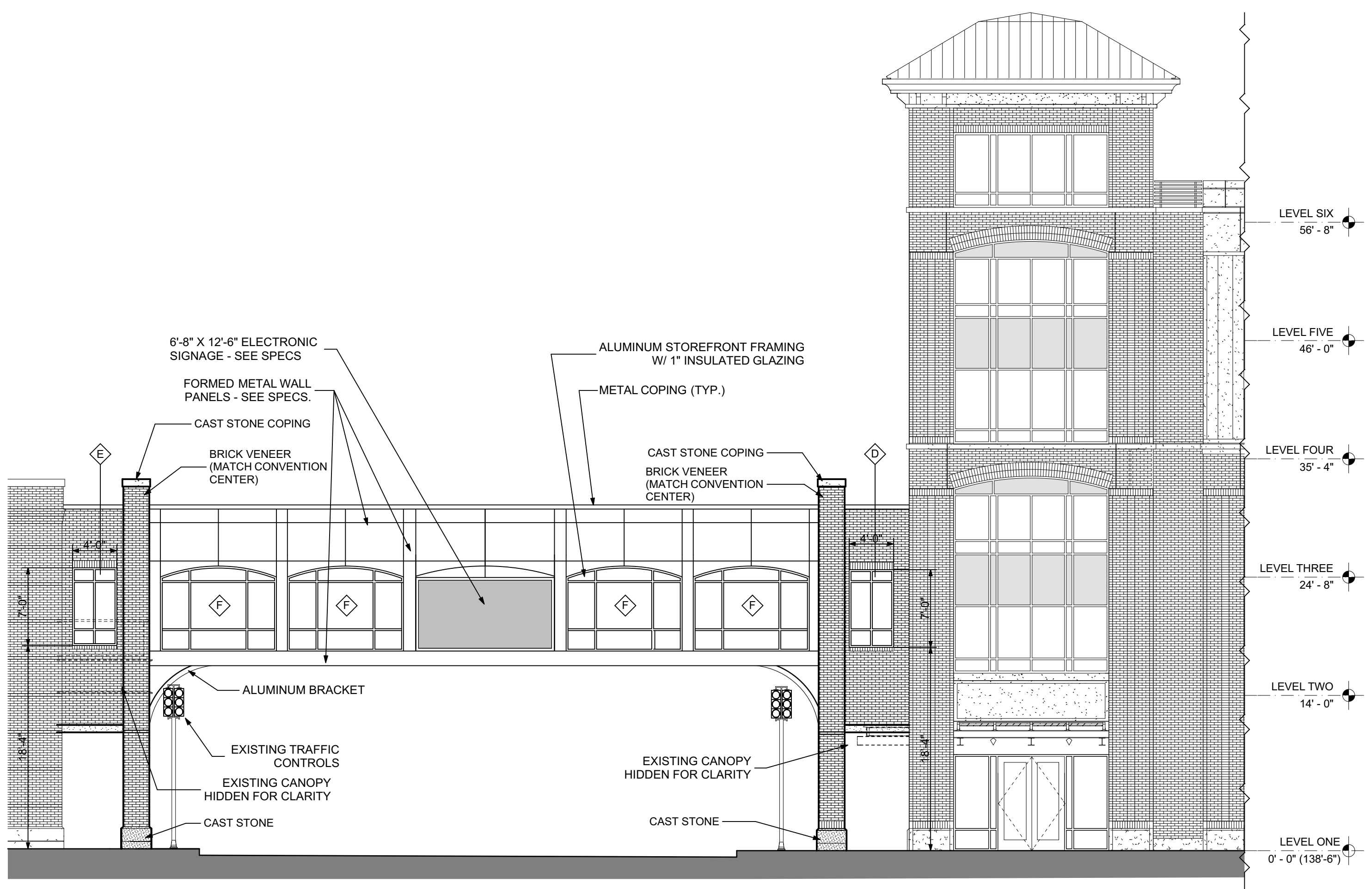

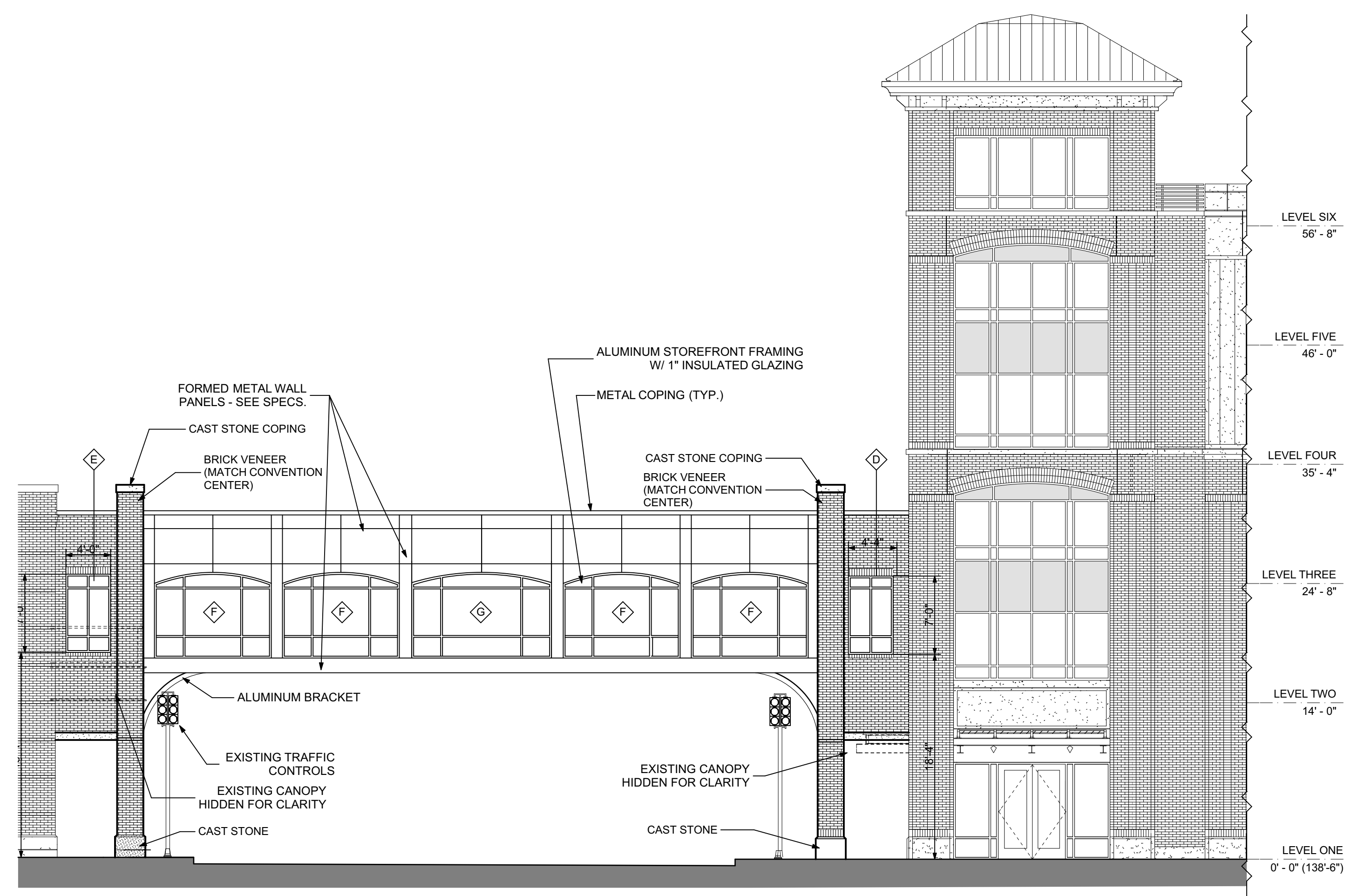
6 EAST ELEVATION

On April 5th, RWA presented the attached list of value engineering options for our consideration. The accepted alternates are noted along with its associated cost reduction. Central Services recommends that we award the contract for construction of the Reynolds Street Pedestrian Bridge to R. W. Allen and Associates in the amount of \$1,197,676.00. This represents their proposed cost of \$1,345,000.00 less \$147,324.00 for deductive items 1, 7, 8, 10, 12, 13, and 14 from the attached list.

Sec. 1-10-51. Request for proposals.

Request for proposals shall be handled in the same manner as the bid process as described above for solicitation and awarding of contracts for goods or services with the following exceptions:

- (a) Only the names of the vendors making offers shall be disclosed at the proposal opening.
- (b) Content of the proposals submitted by competing persons shall not be disclosed during the process of the negotiations.
- (c) Proposals shall be open for public inspection only after the award is made.
- (d) Proprietary or confidential information, marked as such in each proposal, shall not be disclosed without the written consent of the offeror.
- (e) Discussions may be conducted with responsible persons submitting a proposal determined to have a reasonable chance of being selected for the award. These discussions may be held for the purpose of clarification to assure a full understanding of the solicitation requirement and responsiveness thereto.
- (f) Revisions may be permitted after submissions and prior to award for the purpose of obtaining the best and final offers.
- (g) In conducting discussions with the persons submitting the proposals, there shall be no disclosure of any information derived from the other persons submitting proposals.

Sec. 1-10-52. Sealed proposals.

- (a) *Conditions for use.* The competitive sealed proposals method may be utilized when the Augusta, Georgia Administrator approves the written justification of the Procurement Director or using agency head that the sealed bid method is not in the best interest of Augusta, Georgia. Generally, this method may be used when competitive sealed bidding (involving the preparation of detailed and specific specifications) is either not practicable or not advantageous to Augusta, Georgia. Augusta, Georgia is not restricted from using alternative procurement methods for obtaining the best value on any procurement, such as Construction Management at Risk, Design/Build, etc.
- (b) *Request for proposals.* Competitive sealed proposals shall be solicited through a request for proposals (RFP).

- (c) *Public notice.* Adequate public notice of the request for proposals shall be given in the same manner as provided in section 1-10- 50(c)(Public Notice and Bidder's List); provided the normal period of time between notice and receipt of proposals minimally shall be fifteen (15) calendar days.
- (d) *Pre-proposal conference.* A pre-proposal conference may be scheduled at least five (5) days prior to the date set for receipt of proposals, and notice shall be handled in a manner similar to section 1-10-50(c)-Public Notice and Bidder's List. No information provided at such pre-proposal conference shall be binding upon Augusta, Georgia unless provided in writing to all offerors.
- (e) *Receipt of proposals.* Proposals will be received at the time and place designated in the request for proposals, complete with bidder qualification and technical information. No late proposals shall be accepted. Price information shall be separated from the proposal in a sealed envelope and opened only after the proposals have been reviewed and ranked.

The names of the offerors will be identified at the proposal acceptance; however, no proposal will be handled so as to permit disclosure of the detailed contents of the response until after award of contract. A record of all responses shall be prepared and maintained for the files and audit purposes.

- (f) *Public inspection.* The responses will be open for public inspection only after contract award. Proprietary or confidential information marked as such in each proposal will not be disclosed without written consent of the offeror.
- (g) *Evaluation and selection.* The request for proposals shall state the relative importance of price and other evaluation factors that will be used in the context of proposal evaluation and contract award. (Pricing proposals will not be opened until the proposals have been reviewed and ranked). Such evaluation factors may include, but not be limited to:
 - (1) The ability, capacity, and skill of the offeror to perform the contract or provide the services required;
 - (2) The capability of the offeror to perform the contract or provide the service promptly or within the time specified, without delay or interference;
 - (3) The character, integrity, reputation, judgment, experience, and efficiency of the offeror;
 - (4) The quality of performance on previous contracts;
 - (5) The previous and existing compliance by the offeror with laws and

ordinances relating to the contract or services;

- (6) The sufficiency of the financial resources of the offeror relating to his ability to perform the contract;
 - (7) The quality, availability, and adaptability of the supplies or services to the particular use required; and

Background:	In the interest of public safety, Augusta committed SPLOST funds to construct a pedestrian bridge from the second level of the Reynolds Street Parking Deck to the second level of the Augusta owned, Marriott operated, Trade and Exhibit Center. To insure that Augusta received the best value for their investment, it was decided to consider qualifications and pricing in securing a contractor to undertake this project. RFP 17-310 was issued through the Procurement Department with proposals received on January 10, 2018.
Analysis:	Qualifications presented by each firm were reviewed by the Evaluation Committee on March 12, 2018 and R. W. Allen and Associates of Augusta, GA was judged to represent the best combination of qualifications and price for the project. The proposed price, as submitted, was \$1,345,000.00. Central Services recommends award of the project to R. W. Allen and Associates in the amount of \$1,221,118.00.
Financial Impact:	The cost of the project is \$1,221,118.00.
Alternatives:	1. Award contract to construct a Pedestrian Bridge the suspended over Reynolds Street Pedestrian Bridge between the Parking Deck to and the Trade and Exhibition Center to R. W. Allen and Associates of Augusta in the amount of \$1,221,118.00 2. Do not approve award the contract.
